## President's Message

President Hal Delaplane submitted a president's message summarizing activities in 2018 which was distributed by mail to members in January. In it he touted the achievements of the conservancy over the past year. Included in these accomplishments was the Conservancy's being assigned stewardship of a 208-acre tract of county-owned land in the Mattawoman watershed informally known as the "Tech Park." This conservation easement was not an easy decision for the county with many local development-interested groups still holding out hope that this would become an economic driver for the area. But in the end, after weighing options at numerous public hearings, at which The Conservancy was represented, the county elected that the preservation value and it's value for preservation, environmental education, and passive recreation outweighed the changes for development.

Otherwise, The Conservancy was busy monitoring the status of conservation easements, and spreading the message of environmental preservation and natural resource conservation at outreach events such as ArtsFest, Nanjemoy Heritage Day and the Southern Maryland Crops Conference.

### Partners in Preservation

The Conservancy for Charles County is a county-wide land trust that is dedicated to environmental preservation in the county. But it's not the only preservation-minded organization in the county. The Conservancy is interested in working closer with other organizations.

### The Port Tobacco River Conservancy

The Port Tobacco River Conservancy (PTRC), under the leadership of president Tina Wilson, is active in cleanup and preservation in the Port Tobacco River Watershed. Not only does this organization organize cleanup efforts at



Chapel Point State Park and the new Port Tobacco River Park, but hosts monthly social engagements known as Green Drinks. Also, the PTRC recently hosted an annual Chocolate Fest on February 1<sup>st</sup> to raise funds for a planned environmental education center at James Craik Elementary School in Pomfret.

#### Mattawoman Watershed Society

The Mattawoman Watershed Society protects land in the Mattawoman Creek's watershed. They were active last year in opposing a natural gas compressor station near Bryan's Road.



Under joint pressure from the Mattawoman Watershed Society and Mt. Vernon Ladies Association, Dominion Energy's permit application for special zoning was denied, and Dominion decided not to contest that decision.

## **Education and Outreach**

In 2018, Conservancy Board Member, Chris Zabriskie, attended the Land Trust Alliance Rally in Pittsburgh, PA. This three-day event allowed him, a new board member since the end of 2017, to learn more about land conservation, strategies for managing land easements, ways to promote outdoor engagement and education, and make contacts with other like-minded people in the United States who meet each year to discuss how best to protect our lands. The 2019 event will be held in Raleigh-Durham, NC from October 16<sup>th</sup> through 19<sup>th</sup>. People interested in attending should contact the Conservancy to find out what is required to participate, and how such knowledge and education can be parleyed to the benefit of the county. The 2019 Maryland Land Conservation Conference will take place May 16-17<sup>th</sup> at the Maritime Conference Center in Linthicum Heights, MD. This is largest conservation gathering and only land



trust convocation of its kind in Maryland. Admission will be \$100 and the agenda is still being finalized, but should include a number of topics of interest to land conservation and environmental preservation specific to Maryland and the Chesapeake Bay watershed.

# Our Heritage

At The Conservancy's fall membership meeting on October 19<sup>th</sup>, long-time member and former board member, Lloyd Bowling, Sr., was honored for his service and dedication to preserving the landscape in Charles



County by bestowing on him the annual "Heritage Award". Lloyd was in attendance to accept the award, but died peacefully at his home, Westwood Manor, in early December. Rather than as a plaque or certificate, The Conservancy decided to honor Lloyd's Heritage Award with a permanent memorial, a brick in front of the Port Tobacco Players' theater in La Plata. Lloyd shared a life-long passion for community theater along with environmental preservation having appeared in the second-ever production of PTP in 1949. Another permanent legacy... Lloyd placed his family estate, Westwood Manor, a historic 18th century property on Allen's Fresh in Charlotte Hall, MD, under a conservation easement to preserve the natural viewscapes found there in perpetuity. The Conservancy for Charles County will continue to monitor the stewardship of this property to make sure that Lloyd's vision and legacy remains preserved.
